- Under the Superannuation Industry (Supervision) Act 1993, super funds are authorised to collect your TFN, which will only be used for lawful purposes. These purposes may change in the future as a result of legislative change.
- If you transfer your super to another fund the trustee of your super fund will disclose your TFN to the other super provider, unless you tell them not to in writing.
- At your request, AustralianSuper will use your TFN to conduct a search for any lost super you may have with the ATO or other super funds. To request this search go to australiansuper.com/FindAndCombine and log into your account. Any lost super found will be auto-consolidated into your AustralianSuper account as soon as it's found.

We're authorised under super law to collect, use and disclose your Tax File Number (TFN). You don't have to provide your TFN, but if we have it, we'll be able to accept all types of contributions into your account, you won't pay more tax than you need to and it'll be easier to find your super.
